#### MISSION STATEMENT

Latin American Motorcycle Association (LAMA) was founded to create and organize safe and exiting activities for its members and for all bikers, such as tours, picnics, motorcycle sport events, etc. We participate in and organize many local community activities; we offer fellowship and community as well as vast quantities of knowledge that might otherwise take you longer to acquire. We would like to welcome you to our brotherhood.

#### MEMBERSHIP INFORMATION

JOINING (Very simple process)

First off this is a process that takes a while. Not everyone is cut out to ride with an association like LAMA, but if an individual rider is interested in joining our chapter, he or she would have to start coming around to our meetings, rides, events etc. and get to know some of our members. The individual rider should show some interest in being around the group and possibly joining the chapter. Once the individual decides to be a member of the chapter, he or she would be offered the chance to be a prospect in said chapter.

After a period of three months the prospect member will be voted by the committee of the chapter to become a probate, and shall be offered to wear the rockers.

After another three month period as probate; he or she shall be voted in by the committee as to such individual should be given full colors and become a full member of LAMA and become part of the San Antonio Chapter.

#### **REMEMBER!**

- 1. LAMA DOES NOT GIVE COLORS AWAY, YOU HAVE TO EARN THE RIGHT TO WEAR OUR COLORS.
- 2. WE DON'T LET JUST ANYONE IN. THAT WOULD COMPROMISE OUR BROTHERHOOD.
- 3. FAILURE TO MEET LAMA RULES AND REGULATIONS SHALL BE IMMEDIATELY TERMINATED AND STRIPPED OF COLORS.

## QUALIFICATIONS:

## RULES FOR CHAPTER MEMBERS OF L.AM.A.

- 1. Fill out an application for national membership and send it to the Chicago Headquarters with a \$48.00 check payable to Latin American Motorcycle Association, 3519 W. Fullerton Avenue, Chicago, Illinois 60647. You will receive an International membership patch to be worn on the front left side of your official leather vest. The date on your application is the official start date of your LAMA membership dues with the Chicago headquarters. Your national fee must be paid on or before this date every year. (Annual dues).
- 2. You must be sponsored by a chapter member who must sign the application along with the chapter president.
- 3. You must own a legally registered motorcycle of 650cc. displacement or larger.
- 4. You must be presently employed and show proof thereof.
- 5. You must have a current motorcycle license, license plate, and proof of insurance.
- 6. You must agree to attend at least one monthly meeting per month.
- 7. Once accepted by the chapter the prospect must wear a "P" patch for a period of six months to be worn on the back of a black leather vest with no other decorations (MANDATORY)
- 8. You will sign an agreement to return LAMA colors back to LAMA if for any reason your membership is terminated or resigns as a member, and should accept the fact there are no refunds.

#### **RULES OF CONDUCT**

- 1. Absolutely no fighting is tolerated among the members. This is considered a very serious offense.
- 2. Absolutely no illegal activities will be tolerated in our chapter including gambling, use of any drugs or its sales, etc.
- 3. All women are to be treated with respect and as our equal.
- 4. Absolutely no hot roding, burnouts, popping wheelies, hot dogging or any type of an unsafe act will be tolerated in our chapter or on any runs.
- 5. A chapter member too drunk to handle a vehicle will have their keys taken away by the highest ranking member on sight, forcibly if necessary.
- 6. Remember people might not know you by name, but they will remember your colors.

## DUES:

LAMA is a non-profit organization therefore in order for all members to and enjoy future activities such as picnics, rallies or a tour out of state a collection of dues among the active members is necessary.

- Dues are \$20.00 a month.
- All dues shall be handed to the appointed officer.
- Any full member who has not paid dues for a period of 120 days will be terminated and lose all privileges.
- A member terminated must return his/her colors immediately to the president of the chapter as per regulation.

### PROSPECTS/PROBATES:

A prospect/Probate member – Is an individual who is interested in becoming a full member of a LAMA chapter. A Prospect/Probate shall be treated with respect; all full members of the chapter shall guide and motivate prospective members in a positive way without badgering or ridiculing him or her. As members we are also educators to the prospect/probate to teach him/her the rules and regulations of our association and the lifestyle of bikers.

#### All Prospects and Probates must:

- Be sponsored by a full member
- Willing to participate in all LAMA runs, meeting, runs etc., to include duties and monthly dues
- Wear the "P" patch on the back of the vest with no other decorations.
- Not be a participant in any chapter elections.
- Prospects can acquire an extra set of "p" colors for a spouse after filling out an application and paying the proper fees for said person.
- After three months the chapter members can vote on whether to promote the prospect to probate. If the prospect is voted in by the members then he/she shall become a probate and will be allowed to wear the rockers. After another three month period the probate shall be voted again by chapter members. If members of the chapter vote yes on the Probate, then he/she shall be given full membership.
- A Prospect or a Probate can be terminated by the president of the chapter at any time without the consent or vote of the members of the chapter, as for any reason the president feels to terminate due: Endanger to the moral and welfare of the other members and the association, substandard performance of duties, failure to pay dues, failure to meet LAMA rules and regulations.

# AMENDMENTS (HEADQUARTERS CHICAGO)

- 1980 No officer can terminate a full member. Once a prospect is promoted to full member the only way his membership can be terminated is by a simple majority vote. In an officials meeting.
- 1981 Women are to be accepted as full members and accorded the same privileges as male members. The criteria for female membership are the same as for male membership.
- 1983 Officers of LAMA must be full members. Spouse of members cannot hold office. In case of a husband and wife who are both full members, only one can hold office. Other than that it would be a conflict of interest.
- 1985 In the event of a mortal accident of a member, LAMA will donate a sum of no less than one thousand dollars to who ever is deemed financially responsible for the funeral arrangements of said member.
- 1996 The LAMA colors (name and logo) are solely property of the H.Q. chapter in Chicago. The colors are to be accorded the same respect as the flag of a country.
- 1. The name and logo of LAMA are permanent. No committee, elected official, chapter or individual can change, mutilate or redesign them.
- 2. Colors to qualifying members should only be awarded at official meetings, unless a special event is designated by the president to award the colors. Awarding the colors should be a ceremonial event.

# TOURING (RULES OF THE ROAD, BASIC)

- 1. When participating on runs, all members will have a 30 minute grace period before kickstand go up.
- 2. All members should strive to leave together and return together as a team.
- 3. All driving should be done in staggered twos with the highest ranking officer in front or when road director appoints a member of the team. Road formation shall be performed according to road conditions, traffic, and weather.
- 4. Passing is not permitted when riding in ranks.
